## On changes to the draft decision on the third issue of the agenda and notice on holding the Annual General Meeting of Shareholders of JSC «CREDITWEST BANK»

Considering the changes due to the error correction to the project decision of the third issue of the Agenda and to the notice about on the holding of the Annual Remote General Meeting of Shareholders of Joint Stock Company «WEST FINANCE AND CREDIT BANK»

### Project of the decision on the third issue of the agenda:

- "3.1. To approve the results of the Bank's financial and economic activities for 2022 and the Bank's annual report for the year 2022, which includes the Bank's annual financial statements for 2022 in accordance with international financial reporting standards.
- 3.2. To approve the Bank's financial result for the year 2022, namely the losses in amount of UAH 7 759 472,09 (Seven million seven hundred fifty nine thousand four hundred seventy two UAH. 09 kopecks) and cover it as follows:

To direct part of the undistributed profit of the Bank for the year 2021 in amount of UAH 7 759 472,09 (Seven million seven hundred fifty nine thousand four hundred seventy two UAH. 09 kopecks to cover the Bank's losses for the year 2022.
